1. Approval of minutes

- a. Action Taken: Minutes for May 16, approved unanimously
- 2. Report on MBI/EOHED, Comcast, and other local meetings that are not design specific
 - a. Hawley RedZone recap
 - i. Cheryl missed the meeting but described what was learned in the Q&A session.
 - 1. Plan is to deploy LTE at speeds of 25/3
 - 2. Cost for this plan is expected to be \$59.99
 - Four towns are asked to give RedZone a 90 day window to prepare a free design
 - 4. RedZone was asked by MBI to propose a solution
 - 5. RedZone will be looking at applying for CAF II money to supplement the town broadband funding
 - 6. All four towns: Hawley, Savoy, Monroe and Florida must say yes for the planning to move forward.
 - RedZone is working with WG&E for some towns exploring wireless. Royalston was mentioned by name, where WG&E is serving as project manager.
 - 8. RedZone looks to the 4-town area as a base from which to expand in Western Mass.
