- a. Status of Obear contract
 - i. Bob has followed up. No response.

3. Status of Make-Ready

 - i. No update
- b. Town Hall Exterior
 - i. Danek Excavating has completed most of the work.
 - ii. Punch list
 - 1. No strings coming out of the risers at the poles. Check in on the installation of pull strings.
 - 2. Seal tops of the risers.
 - 3. Cap the end of the conduit.
 - 4. Bring in loam and bring it flush with the grade
 - 5. Asphalt patch on the sidewalk
 - 6. Vault bolts need to be installed
 - 7. Mortar and seal the foundation
 - 8. Use the conduit next to the wall and keep the other as a spare.
 - 9. Excess materials (sweeps, etc.) why?
 - iii. Weather cap for conduit into the riser.
- c. Railroads
 - i. Long Bridge
 - WG&E sent the National Grid sketch of the long bridge. Very expensive (\$90,000). Looking for alternatives.
 - 2. Town will try to go behind the crossarms on the road and if it needs to be on the west side of the gate and be higher than the minimum for crossing.
 - a. Doug shared the road plans for the area of the crossing.
 - b. Directional drilling could be an alternative, but we're not sure about the cost and permissioning needed from the railroads.

- i. Consider trenching up to the tracks, then under.
- ii. Bob will contact Eagle One for advice.
- ii. Tower Road
 - 1. Response from the railroad, we are approved.
 - 2. Bob to follow up with Mike Twidle.
 - 3. Contractor will need to contact the real estate office for insurance and access rules.
 - 4. Bob will ask WG&E about rigid conduit, who runs it and when.
