- i. Long Bridge
  - 1. Doug reviewed the site of the railroad.
  - 2. Paved amount is wider than the town ownership
  - 3. Go through the center of the crossarms?
  - 4. Pole height is a problem but it is scheduled to be replaced.
  - 5. Issue is that we need to be 27' above the railroad, clear the crossarms, and land in the proper section of the pole for fiber outside of the electrical space.
  - 6. Propose an aerial RR crossing from a town owed extra tall pole on the North side of 8A to a new pole on the South side of 8A as close to National Grid pole as allowed. Getting permission to run the fiber down the pole to the fiber space. Sketch was created in the meeting. Bob will check this with WG&E.
  - 7. Sarah Reynolds will ask Gordon Hathaway to provide the easements around the Long Bridge. Jonathan Eikman at Doppleman and Page is

handling the easements. Sarah will also reach out to Gill Engineering for any survey information.
