## 2. Operations

- a. Consideration of long-term ISP contract with WCF and these rates
- b. We will consider a short-term contract but not the 10 year one, which is too long.

## 3. Planning Board Update on New Construction

- a. New construction in housing subdivisions should include broadband.
  - i. If you build a new road, there are town requirements that apply, such as a requirement to pay to put in streetlights.
  - ii. In that fashion, broadband should be included in the subdivision plan and pay for the inclusion. Suggest that we ask the developer to extend the distribution network along the roads, and each residence would pay for installation connections.
  - iii. How would we pay for the cost of extending / improving the capacity of the distribution network?
    - 1. This is similar to a water system? Is there a general way they handle this?
    - 2. Does the town want to subsidize some services to encourage building?
  - iv. Bob will be meeting with the Planning Board on November 17th.
