Public Hearing

6:30 Brian and Christine Dupree / Stagecoach Auto — amendment of 1994 Special Permit to sell used cars at Stagecoach Auto Repair, 180 Rte. 8A North, to include a site plan.

Bob Nelson opened the hearing at 6:30 and read the hearing notice. Christina Dupree was there to represent Stagecoach Auto as Brian Dupree wasn't feeling well.

The Board viewed the map with the 4 parking spaces laid out.

Bob Nelson sought a motion to approve the addition of the drawing of the four spaces to the 1994 Special Permit to sell used cars. Liz Bouyea made the Motion. Jennifer Mooney seconded the Motion. All in favor.

 Bill spoke to Robert Tatro, property owner at 2071 Rte. 2, who lives in Florida, regarding a permission letter for Topstitch Upholstery to get a Special Permit. Robert would like to have a rental agreement signed before giving a letter. The board will wait.
- 4. Review and edit the Open Space Plan zoning section, and any other Open Space items. The Board edited some passages of the Open Space Plan that are zoning related. Liz took the edits and will give them to Sarah.
- 5. Review the list of consultants Sarah sent the RFP for the Master Plan out to.
 The Board reviewed the list and wondered if they could have it advertised on the CPTC list serve to attract local consultants as well as reaching out to Jeff Lacy who they have worked with, to see if he has a recommendation. They also wondered if it had to be posted somewhere officially as an RFP. Star will check with the administrator.

6. Review Oxbow Inn Special Permit

The Board looked at the permits on file for the Oxbow Motel. The motel pre-dates Charlemont's Zoning bylaws. There are changes of use permits, regarding a particular building at the inn, but no original permit. Jen mentioned that the new owners had spoken to her about renting some of the units month-to-month and keeping some of the rooms as motel rooms. Lori will speak to the Building Inspector to see if the new month-to-month rental offering requires a change of use or if it can fall under the current use.
