They would like to talk to animal control. They mentioned that the AG does a lot for free as well. Bob said that he should not have roosters. They need to respond to the complaint, they'd like to loop Jim Hawkins back in.

5. 1463 Rte 2. / Olde Willow, parcel division query

1463 is out of the Planning Boards hands, there is enough frontage, and the interested parties would need to move forward on their own or with other Boards.
