- 4. Motion made by Jean B 2<sup>nd</sup> by Erwin R to use \$92.22 from the Memorial Beautification Fund for usage by the FCF for planting flowers at The Fairgrounds. Flowers to be purchased by FCF and receipt to be submitted to P&R. All in favor aye unanimously.
- Motion by Jean B 2<sup>nd</sup> by Jerry G to accept application for a Father's Day Pancake Breakfast to be held June 19<sup>th</sup> from 6am-2pm. Jerry G appointed liaison all in favor aye: Jean B, Steve R, Jerry G, Erwin R Opposed: Rick M.

P&R request a duplicate copy of application. Motion made by Jean B to waive all fees except \$20 deposit 2<sup>nd</sup>

by Jerry G all in favor aye unanimously.

Motion made by Jean B 2<sup>nd</sup> by Rick M to accept application subject to approval by the Board of Health, proof of Insurance by Board of Selectman all conditions and approvals are to met by a July 15<sup>th</sup> deadline. There will be a restricted use of the area that surrounds the front & sides of the Grandstand area. All in favor: aye unanimously.
- 14. Rick Mullen to call a licensed plumber about the necessity to have a licensed plumber to de-winterize & winterize the Fairgrounds water supply.
- 15. April 23<sup>rd</sup> Park & Rec to meet at The Fairgrounds to check the status of any electrical & lighting issues.
- 16. Motion to adjourn at 10:12 pm 2<sup>nd</sup> by Rick Mullen all in favor: aye unanimously.
