- 1. Motion made by Steve R 2<sup>nd</sup> by Todd G to accept minutes from 04/09/12 all in favor aye Jerry G, Todd G, and Steve R
- 2. Motion made by Todd G 2<sup>nd</sup> by Jerry G to accept treasurers report dated 4/09/12 all in favor aye Jerry G, Todd G, and Steve R
- 3. At 7:10 pm Frank & Jen Mooney summarizes their proposal for livery service @ Hawlemont School. All members of Park & Recreation agree the need for this type of service in Town. Debate over access to the back end area known as the soccer field. Rick Mullen makes a case that he believes that the lease between the Town and Hawlemont School District does not provide for leasing the Town property. Research needed. Todd G proposes a possible access by moving backstop and two fences to accommodate such access. Discussion of the field needed as a LNZ for med flights brought up by Steve R., he will inquire of what the radius needs to be and its effect. Ruth Canavo from Con Comm speaks to the setback distance from the Rivers edge as it relates to vehicle sparking. Steve R suggest possible Land opportunities along Rte. 2 from the private sector as an alternative to the usage of Town Public property. Jerry G concurs and suggests that all other avenues of access to the river should be exhausted first. Rick Mullen also states as a reminder that this proposal will be reviewed by Park & Rec on a yearly basis.
