Mr. Bissell is applying for a variance to add a ten foot by twelve foot deck on the north side of his house. Formerly, this building contained a medical office. Mr. Bissell wishes to rent the house as family occupancy. To make the building more livable, Mr. Bissell asks to replace an office entrance with a small deck.

The proposed deck will be twenty-five feet from the north property line. No abutters have objected to this addition.

- Mr. Bissell supplied the necessary property maps and the reason why he is applying for a variance.
- Mr. Bissell will apply for a building permit and meet the requirements of the building inspector.

Therefore, Mr. Gould moved that the variance be granted given that the qualifications have been met. Mr. Mackie seconded and the vote was Mr. Gould yes, Mr. Mackie yes. The Board's findings are attached hereto and made a part of this record.
