- 5. The Board received Building Inspection Reports and an outdoor wood burning furnace permit was issued for Kathryn Hallenbeck at 73 Route 8A North.
- 6. The Board received 5Title V Inspection Reports. The property at 38 Heath Stage Terrace needs further review by the Board, as the well is 99'6" from the septic system. The Board will require a water test prior to issuance of a variance.
- 7. The Board received 8 Septic Pumping Reports.
- 8. The Board reviewed the Regional Fee Structure Recommendation Report. Glen Ayers attended the discussion via speaker phone. Some suggestions to the proposed fee schedule were made. The Temporary Food Permit Fee for several days was reviewed and it was suggested to make the permit good for seven days.
- 9. The Board reviewed correspondence:
 - a. Various notices from the Massachusetts Department of Public Health.
 - b. Glen Ayers Perc Test at 152 Tower Road.
- 10. The Board discussed 122 Main Street. Rob Lingle noted that he spoke with Giesla Walker of the Planning Board about bringing discussion of the property to the "All Board Meeting".
- 11. The Board received a Housing Complaint on 9/25/2012 furnace not working. The matter was referred to Glen Ayers to follow up with the owners.
- 12. The Board discussed Glen Ayer's handling of Title 5 Inspections. The Board considers the present way that Glen is handling these inspections to be sufficient.
